General Data Protection Regulation

Personal data protection is fundamental to all types of organisation. Personal data is a lot more valuable than one can imagine. Data about people makes it possible to develop business models, conduct effective marketing campaigns and develop products and services. But just as for many other assets, there is a need for responsible use based on common rules. Organisations face a web of complex set of regulations surrounding the collection, use, retention and disclosure of information.

The GDPR was intended to make data protection a boardroom issue. It introduced an antitrust-type sanction regime with fines of up to 4% of annual worldwide turnover or €20m, whichever is the greater. These fines apply to breaches of many of the provisions of the GDPR, including failure to comply with the six general data quality principles or carrying out processing without satisfying a condition for processing personal data.
