## General Data Protection Regulation

In 2020, all organisations that process personal data must comply with the General Data Protection Regulation (GDPR), whilst the new ePrivacy Regulation will bring changes to direct marketing rules and new obligations for IT-based communications providers.

The GDPR includes new concepts such as the 'right to be forgotten' which businesses need to fully understand and prepare themselves for. It is not just reputation that is at stake. Breaching the law could give rise to a fine of up to EUR 20 million or 4% of an organisations' global annual turnover, whichever is higher.

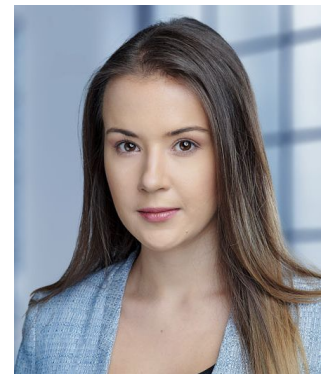
